PROGRAM ELIGIBILITY

- 1. This offer is being made from Zebra Technologies to end users in the form of a rebate for purchases made between January 1, 2017 and December 31, 2017.
- The Program applies to new purchases of qualifying devices (the "Qualifying Products"). End users must purchase Qualifying Products from a Zebra® PartnerConnect reseller ("Reseller").

- 4. For mobile computers, any manufacturers' brand or model of mobile handheld device with a display equal to or greater than 2" is eligible to be traded-in, including Zebra, Motorola, Psion, Symbol and Telxon.
- For printers, any Zebra or competitive thermal barcode or card printer is eligible to be traded-in, but must power up and include the printhead.
- 6. For batteries, batteries from select manufacturers including Zebra, GTS, Harvard, Titan/Tank, Cut Rate, Cameron Sino are eligible to be traded-in. Traded-in batteries must be comparable to the one being purchased and must be a separate line item on the Reseller invoice. Any end user participating in Zebra's battery maintenance or battery refresh programs is not eligible for this Program.
